2025 ANNUAL REPORT

Accomplishments

Food Bank

- Volunteers worked 38,448 hours in 2025 to provide food assistance to people in need and school backpacks to hungry children.
- In 2025, the food bank received 1,763,418 pounds of food including 109,668 pounds from food drives.
- The Student Snack Packs and the Family Emergency Food Packs have continued to help satisfy the need brought on by food insecurity.
 - The Student Snack Packs are a supply of snacks for school children. The packs are provided to the Title 1 Schools in the West Ada School District upon request from a teacher.
 - The Family Emergency Food Packs are a 2-day emergency food supply. The packs are provided to schools within the West Ada School District, when requested by a counselor. The schools provide the packs to families of students facing an immediate food crisis.
 - The Family Emergency Food Packs are also provided to families placed in housing by CATCH, Inc. as well as the Agency on Aging when needed.

Food Pantry

- We provided food for 25,579 household visits in 2025, up 3% from 2024
- These household visits benefited 79,057 individuals, up 4% from 2024
- 1,620,366 pounds of food was distributed in 2025

Backpack Program

The backpack program provides a pack of food each week to students who have been identified by school counselors as being food insecure. The food packs contain two breakfast meals with shelf stable milk, two lunches, two dinner entrees, fruit, and snacks. The food packs are delivered to the schools on Thursday of each week that school is in

session to be given to the needy students on Friday.

- 27,392 food packs serving an average of 783 children weekly were provided in 2025

Demographics

Food Pantry

- Currently serving 42 communities throughout the Treasure Valley area and beyond with 95% of the clients residing in Ada and Canyon counties
- 33% of those benefiting from the food pantry services are under the age of 18, 57% are between the ages of 18 and 59, and 10% are 60 or older

Backpack Program

- Currently serving 56 schools out of the 59 schools within the West Ada School District.
- Of the students receiving food packs, 73% are elementary school age, 17% are middle school age, and 10% are high school age
- 51% of the food packs go to 13 schools in the West Ada School District identified as Title 1 schools

Budget

2025 Cash Requirements \$490,000 (Actual)

- Food Pantry Food Purchases - \$90,500
- Backpack Program Food Purchases - \$93,100
- Operating Expenses - \$144,200
- Capital Expenditures - \$162,200

2026 Cash Requirements \$442,300 (Projected)

- Food Pantry Food Purchases - \$90,000
- Backpack Program Food Purchases - \$93,000
- Operating Expenses - \$111,600
- Capital Expenditures - \$147,700

Operating expenses are for fuel, insurance, utilities, office expenses, repairs and maintenance. We pay no salaries, no vehicle payments, no mortgages and carry no debt whatsoever. Capital expenditures in 2025 and 2026 are for expansion of the backpack storage and preparation area.

Donations

- 92% of the food distributed was donated. The food comes from food drives, private donations, grocery stores, community gardens and local farmers. In 2025, 1,631,528 pounds of food were donated.
- Cash donations in 2025 did not meet our operating and capital costs, forcing us to use some of our reserves.

Services

- **Food Pantry Services** are available Monday, Wednesday, and Thursday each week. Individuals and families within Treasure Valley are permitted two visits per month.
- **School Backpack Program** delivers food packs weekly to children within the West Ada School District when requested.

Organization

- Founded in 1999, the Meridian Food Bank received its IRS 501(c) (3) designation in 2006
- The Meridian Food Bank is an all-volunteer organization. There are no paid positions. Over 250 volunteers are available to conduct day to day operations for both the Food Pantry and the Backpack Program.
- 8 member Board of Directors
- 9 person management team directing daily operations
- Managerial oversight provided by Executive Director
